

# New LED Rebates Available, Starting March 1, 2019\*

To provide our Minnesota business customers with more ways to save energy and money, we're increasing our line of LED rebate offers. These new rebates will be available for qualifying LED fixtures and lamps which have an invoice date of March 1, 2019 or later.

### More rebate options for LED high/low bay fixtures and retrofit kits

Our current rebates offered for high/low bay fixtures and retrofit kits will expand to include more options. Customers will be able to earn these rebates when they replace their existing fluorescent fixtures, in addition to HIDs. The rebate levels for new LED fixtures are the same, whether they're installed to replace either fluorescents or HIDs; but vary depending on the wattage of the new LED fixtures and whether or not they are DLC-qualified.

### New rebates for T5 LED linear tubes

Our current rebates offered for LED linear tubes will be expanded to include T5 LED tubes, in addition to T8 tubes. These rebates are available for new LED tubes which are installed to replace existing T5, T8, or T12 fluorescents. (Note: non-installed Type A and Type B lamps purchased in cases can qualify for rebates if they will be stored on the customer's premises.)
